Schools may accept enrolments from outside their designated area if places are available. Such applications are subject to department policies.

If the demand for local enrolment exceeds the number of places available, out-of-area enrolments will not be available. **The Forest High School has a school cap**, and must ensure that each year group has a buffer to allow for local area enrolments throughout the year.

The following criteria are used to assess all other applications for non-local enrolment. You must address one or more of the following criteria, and provide evidence in support of your declaration. We reserve the right to request additional evidence, including contact details of external agencies or individuals who can verify the information provided. You must also provide your TWO most recent school reports, and your most recent NAPLAN results.

The Forest High School non-local placement panel convene on the following dates to assess submitted applications. The panel consists of a Deputy Principal, Year Adviser, and Parent Representative.

Applicants will be notified, in writing, within 10 working days of the panel's decision.

The examples listed in italics below should be used as a guide only. Demonstrated evidence against the criteria does not guarantee an offer.

1. Access to a coeducational school 2. Proximity and access to the school, including, but not limited to: - Your home address is geographically closer to The Forest High School than your local school - Your workplace is in our local area and private transport is demonstrably easier than access to your local school

- 3. Availability or combination of subjects, including, but not limited to:
 - Continuity of elective courses in stage 5 or stage 6
 - Electives unique to The Forest High School
- 4. Disability or medical
 - Evidence that The Forest High School has established disability or medical support that cannot be provided at your local school

- 5. Access to programs and support, including, but not limited to:
 - Band program (if not offered at your local school)
 - Aboriginal Education Officer Support

6. Compassionate circumstances

Compassionate circumstances cover a broad range of circumstances that are generally beyond the schools control and can only be resolved with placement in your non-local school.

- Legal Reasons (victim of crime, court orders)
- Parent is employed at your local school (conflict of interest)
- Issues with siblings attending the same school (e.g. blended family)
